## DESCRIPTION OF MEMBERSHIP TYPES AND FEES

February 1, 2007

Dayton Golf and Country Club is a private non-profit organization intended for the sole purpose of providing a place of relaxation, socializing, and recreation for its members and their guest. The club has 18 holes of golf, a practice area and green, and a restaurant.

**REGULAR MEMBERSHIP** - A regular membership entitles the member, spouse, and dependent children under 21 years of age, or any age so long as they are attending a college or university full time, to full privileges of the Club.

Initiation Fee: \$0                      Monthly dues: \$75.00 + 6.94 tax = \$81.94

**SENIOR MEMBERSHIP** - Privileges are the same as regular membership. The member must be over 65 years of age.

Initiation Fee: \$0                      Monthly dues: \$70.00 + 6.48 tax = \$76.48

**JUNIOR MEMBERSHIP** - Privileges are the same as a regular membership. The member must be single and less than 26 years of age.

Initiation Fee: \$0                      Monthly dues: \$55.00 + 5.09 tax = \$60.09

**NON-RESIDENT MEMBERSHIP** - Privileges are the same as a regular membership. The member must reside outside a thirty mile radius of Dayton.

Initiation Fee: \$0                      Monthly dues: \$55.00 + 5.09 tax = \$60.09

**SOCIAL MEMBERSHIP**- Social membership entitles the member, spouse, and dependent children under 21 years of age, or any age so long as they are attending a college or university full time, to use of the clubhouse and house functions.

Initiation Fee: \$0                      Monthly dues: \$22.88 + 2.12 tax = \$25.00

Applicants that have an outstanding balance at the club from a previous membership must pay balance in full prior to rejoining. Applicants that have been terminated or resigned within the past 12 months have to pay dues from the time of termination/resignation. All resignations and request for Leave of Absence must be submitted in writing. Forms are available in the Pro Shop. After resigning a former member cannot play golf for a period of 12 months except in leagues and tournaments. All Leave of Absence must be approved by the Board of Directors. During a leave of absence a members playing privileges are suspended. Members whose dues are more than two months delinquent are not allowed to use the Club's facilities under any circumstances until their balance is paid in full.
